## QUICK FACTS

- **Separate legal entity.** The Foundation is a 501 (c) (3) registered in Minnesota.
- **Professionally managed & invested.** The Foundation administers over \$2.0 million in assets.
- **Building for the future.** The Foundation Board distributes approximately 5% out of these funds annually.

## HOW DOES IT WORK?

The Foundation's funds, formed as a result of cooperation between the Church and the Foundation, provide annual support to the ongoing ministries of the Church. The Funds in existence today are:
